It is best if a wetsuit fits the child; have your child try on the wetsuit before purchase! Wetsuits are available for rental at Monterey Bay Kayaks, Sunshine Freestyle, On the Beach, and other local stores. Inexpensive wetsuits are available at many sporting goods and discount stores. The club has life jackets to loan, if necessary.

A lunch should be brought every day. The Club offers a sit-down lunch on Thursdays from 11:30-1:30, and parents are encouraged to join their children for this meal. The cost can be charged to the member's account (prompt payment of club bills is required; delinquent accounts will not be allowed charging privileges). Cash and checks are also accepted.
