***MPYC bylaws require all members to be current on their accounts. Junior Members are subject to the same billing provisions as Regular Members. This means that overdue bills will be charged late fees, names posted, and membership suspended following the MPYC Bylaws procedures stated below. As we extend charging privileges for meals and logowear to our Junior Members, we expect them to be diligent in paying their accounts. Junior Members with delinquent accounts may be refused participation in Sailing Team and Summer Camp activities until such time as their account balance is paid in full. **Alcoholic beverages may NOT be charged to Junior Member's accounts.*****

**MPYC Bylaws state:**

ARTICLE IX: INITIATION FEES AND DUES Section 3. Indebtedness of the membership shall be due on the 7th day of the billing month or otherwise as the Board of Directors may prescribe. Any Member with indebtedness to the Club not discharged within sixty (60) days from the date of indebtedness shall become delinquent. Delinquent accounts will be charged a late fee of 1.5 per cent of the amount due for each month the account remains delinquent. The name of the delinquent Member shall be posted in the clubhouse, their charging privileges revoked and membership suspended pursuant to the notice and hearing provisions of Article XII until such indebtedness is paid in full. Any member remaining delinquent for a period of four (4) months shall cease to be a Club member (terminated) on the last day of such period and shall forfeit all rights and interests in the Club, subject to the notice and hearing provisions of Article XII.

ARTICLE XII: DISCIPLINE

Any member remaining delinquent for a period of four (4) months shall cease to be a Club member (terminated) on the last day of such period and shall forfeit all rights and interests in the Club, subject to the notice and hearing provisions of Article XII.
