Dear MPYC Member,

Once again, it's time to prepare for another great year of yacht racing. The Race Schedule for 2018 is jam-packed with all the traditional Series Races, Sunset Series and Specialty Races. With lots of exciting events, we are looking forward to another fun year of yacht racing. Please join us!

## **2018 MPYC Race Registration:**

The required racing forms have been posted on the MPYC web site. A link to these forms can be found on the Home page of the MPYC web site ([www.mpyc.org](http://www.mpyc.org)) and in the weekly email blasts through January. Hard copies will also be available at the club. Please feel free to contact me or one of the other race chair committee members for any assistance you may require.

If you are planning on racing this year, even casually, you will need to complete and return the following forms:

- 1) Race Entry form
- 2) Liability Waiver
- 3) Race Committee Duty Commitment
- 4) Race Fees

Additionally, if you are a PHRF racer you will need:

- 5) PHRF Monterey Bay Certificate on file with MPYC. If you did not receive a **Monterey Bay Performance Handicap Racing Fleet Renewal form** from Monterey Bay PHRF committee, or if your boat is new to racing in the Monterey Bay, please contact Mark Chaffey, or SCYC, for information on getting a PHRF certificate for your boat.

## **Race Committee Assignments:**

**January 27<sup>th</sup> 2018 at 12 noon Jerry Stratton will conduct required "Race Committee" training.** It is **mandatory for ALL Skippers** not previously certified on Race.com and strongly recommended for all crew members to attend each year, whether previously certified, or not. Plan on 1:45–3:00 hours, depending on your Race.com experience. To be held at MPYC.

Race Committee assignments will be posted once all skippers have registered. Final copies of the 2018 Race Schedule to include Race Committee assignments will be emailed to each skipper with a confirmation of your entry. The updated Race Schedule will also be available throughout the year on the MPYC web site. (Those who register early will have earlier input to the schedule.)

**New for 2018** – Your **Fleet Captain is your primary contact** if you are unable to get your minimum required Race Committee crew requirement (first exhaust all reasonable options to man RC duty).

**EARLY REGISTRATION DISCOUNT:** Members who register for the 2018 Race Season by January 25<sup>th</sup> 2018 (one month prior to the Feb 25<sup>th</sup> Tune up race) will enjoy 2018 discounted fees prior to the 2018 Regular registration fee.

## **MPYC 2018 Sailing Instructions (SI)**

### **1 RULES**

**1.1** The regatta will be governed by the rules as defined in the Racing Rules of Sailing, 2017– 2020 (RRS), unless modified by these instructions. Participants must also conform to Federal and State laws and Regulations, and Coast Guard Directives as it pertains to recreational boating ([www.uscgboating.org](http://www.uscgboating.org)).

**1.2** Class and PHRF racing rules will apply unless modified by MPYC SI, RC or NOR.

### **2 NOTICES TO COMPETITORS**

Notices to competitors will be posted on the Race Board at the MPYC clubhouse, or for races starting at Stillwater YC (SYC) the notices will be posted at the foot of the SYC pier.

### **3 CHANGES TO SAILING INSTRUCTIONS**

**3.1** On the day of a race, any change to the SI will be posted 2 hours before the first start. If there is any change to the schedule of races, it shall be posted by 20:00 on the day before the change will take effect.

**3.2** Oral changes to the SI may be given only on the water. Oral changes may be made only by the RC and **must** be given to each individual boat. RC must record acknowledgement of each competing boat of the change. Oral changes should only be given in the most unusual circumstances when those circumstances preclude procedures in 3.1 above. All oral changes must be governed by the rules as defined in the RRS.

### **4 SIGNALS MADE ASHORE**

**4.1** Signals made ashore will be displayed at the flagpole atop the MPYC Clubhouse.

**4.2** When flag AP is displayed ashore, 1 minute is replaced with not less than 60 minutes in race signal AP.

### **5 RACING SCHEDULE**

**5.1** The schedule of races is listed in the MPYC 2018 Racing Schedule. Additional days may be scheduled if races are not completed as scheduled or if the race committee considers it unlikely that races will be completed as scheduled.

**5.2** The MPYC 2018 Season Championship for each One Design Class consists of three separate Series: Spring, Summer, and Fall as listed in the Schedule. The MPYC 2018 Season Championship for each PHRF Class consists of three separate series: Spring, Summer and Fall as listed in the Schedule.

**5.3** Three races must be completed to constitute a series.

**5.4** The scheduled start time of the first race of each day is listed in the MPYC 2018 Racing Schedule. The warning signal for this first race will be given no earlier than 5 minutes prior to the time listed.

**5.5** When more than one race (or sequence of races, for two or more classes) will be held on the same day, the warning signal for each succeeding race will be made as soon as practicable.

**5.6** The One Design and PHRF classes will have the number of races indicated in the Schedule for each scheduled Series Race day. For all other races the number of races each day is set by the RC or a NOR.

## **6 CLASS FLAGS**

These signaling flags are used as Class Flags: to identify One Design classes the class sail insignia on a white background; to identify the PHRF A class the A signal; to identify the PHRF B class the B signal; to identify PHRF A, and B classes the letters PHRF in green on a white background.

## **7 RACING AREAS**

The attached 2018 MPYC Course Sheet shows the location of racing areas, fixed marks and the coded courses. Courses are not limited to those listed.

## **8 THE COURSES**

**8.1** A boat shall start, sail the course described in the sailing instructions or by the RC boat and finish. While doing so, she may leave on either side a mark that does not begin, bound or end the leg she is sailing. After finishing she need not cross the finishing line completely.

**8.2** Courses may be selected from the current Course Sheet, displayed from the RC Boat, or by special written instructions. Courses may be described using a sequence of the mark rounding codes of SI 9.1. A course for a specific class may be prefixed with an unambiguous class abbreviation.

**8.3** Multi-lap courses may be indicated using the letter "X" and a whole number to indicate that the given course is to be repeatedly sailed that number of laps. If a course is to be sailed repeatedly, boats must sail through the start line to complete each lap prior to starting a subsequent lap.

**8.4** No later than the warning signal, the RC signal boat will display the course to be sailed.

## **9 MARKS AND OBSTRUCTIONS**

**9.1** The 2018 MPYC Course Sheet describes the racing area and marks of the course(s). Mark descriptions are abbreviated to a short uppercase letter or number code followed by a smaller letter P or S to indicate that the mark is to be left to port or starboard respectively per RRS 28.1.

**9.2** If the F Mark is to be a finishing mark and the RC is displaying the course, the display will indicate the finish as a Z followed by a small P or S to indicate how the Mark is to be left at the finish.

**9.5** Ground attached kelp and dense floating masses of kelp are obstructions.

**9.6** In the event of a missing mark, if the mark is not replaced or substituted by the race committee per RRS 34 (a) and (b), then the race is automatically abandoned. This modifies RRS rule 34.

## **10 THE START**

**10.1** The starting line will be between a staff displaying an orange flag and a nearby floating mark.

**10.2** Boats whose warning signal has not been made shall avoid the starting area.

**10.3** A boat starting later than 10 minutes after the starting signal will be scored "Did Not Start." This changes RRS rule A 4.

## **11 THE FINISH**

**11.1** Finishing boats will cross the finishing line “**from the course side.**” Except when shortening the course, the finishing line shall be between a staff displaying an orange flag and a nearby floating mark (Usually the original starting mark).

**11.2** F is a mark of the course. When designated as the finish mark it will be called Z, followed by a small P or S to indicate how the mark shall be left.

## **12 TAKING A PENALTY**

**12.1** A boat may take a One Turn Penalty when she may have broken a rule of RRS Part 2 while *racing* and must comply with RRS rule 44.2: this includes a Rule 31 violation—Touching a Mark. If a boat breaks a rule of RRS Part 2 within the three-length zone of any rounding or passing marks, her penalty shall be a TWO TURNS penalty in compliance with RRS 44.2. This modifies RRS 44.1.

**12.2** If the boat caused injury or serious damage or gained a significant advantage in the race or series by her breach of rule of RRS Part 2 her penalty shall be to retire.

## **13 TIME LIMITS**

Boats failing to finish within the following time after the first boat of its class sails the course and finishes will be scored “Did Not Finish.” This changes rules 35 and A 4.

All Classes	less than 10 NM	30 minutes
PHRF A&B	less than 20 NM	90 minutes
All Classes	20 NM and greater	90 minutes

## **14 PROTESTS, ARBITRATION AND REDRESS**

**14.1** For protests alleging breach of a rule of RRS Part 2, arbitration is required prior to a protest hearing. The arbiter will be mutually chosen and agreed by the protestor and the protestee. One representative of each party will meet with the arbiter to give testimony; no witnesses are allowed. The arbiter will decide:

- (a) No boat broke a rule, if the representatives agree, the protest will be withdrawn; or
- (b) One or both boats broke a rule, the parties may then accept a 40% scoring penalty for that race (this modifies RRS 44.3(c)) and the protest will be withdrawn; or
- (c) The protest does not qualify for arbitration and a full hearing must be held.
- (d) If any representative disagrees in options (a) or (b), then a full hearing will ensue. This modifies RRS Part 5.

**14.2** For each class, the protest time limit is 2 hours after the last boat of that class has finished the last race of the day. The same protest time limit applies to all protests by the race committee and protest committee based on the last race of all classes for the day. A Request for Redress shall be delivered to the race office within the protest time limit based on the last boat of that class finishing the last race of the day. The protest Committee shall extend the time, if there is good reason to do so or as soon as reasonably possible after learning of the reasons for making the request. This changes rules 61.3 and 62.2.

**14.3** Notices will be posted within a reasonable time after the protest time limit to inform competitors of hearings in which they are parties or named as witnesses. Hearings will be held at the place and time posted.

**14.4** Protest forms are available at the race office. Protests shall be delivered to an RC official within the protest time limit.

## 15 SCORING

**15.1** The Low Point System, RRS Appendix A, shall be used as modified here:

(a) The MPYC 2018 Season Championship standings will be determined after deducting from a boat's score of all Qualifying Series the number of worst scores in a like manner to RRS Appendix A2.

<u>Class</u>	<u>Number Deducted</u>
All one design	3
PHRF	1 for each 5 races

(b) No scores may be excluded from a series standing. This changes RRS A2.

(c) Scoring for the Sunset Series is based on the number of first place finishes only.

(d) Terms and their respective scores:

(New for 2018 in order to standardize with U.S. Sailing and adapt to Regatta Network penalties will be based on Finishers rather than Starters. DNF will still receive one less point than DNC.)

(DNF) Did Not Finish - shall receive a score equivalent to the total number of boats that properly "finished" the race (Finishers + 1)

(DNS) Did Not Start - shall receive a score equivalent to the total number of boats that properly "finished" the race plus one (Finishers + 1)

(DNC) Did Not Compete or Did Not Come - shall receive a score equivalent to the total number of boats that properly "finished" the race plus one (Finishers + 1)

(DSQ) Disqualified - A boat which is disqualified from a race shall receive a score equivalent to the total number of boats that properly "finished" the race plus two (Finishers + 2)

(RET) Retire - A boat which voluntarily retires from a race after properly starting shall receive a score equivalent to the total number of boats that properly "finished" plus one (Finishers + 1).

Note - The "RET" scoring provision is intended for a yacht which, 1) acknowledges failure in sailing designated course, 2) acknowledges it has fouled a competitor (but does not take on-water penalty), 3) acknowledges failure to properly start, or 4) violates any other applicable rule of sailing as defined within RRS 2017. A boat which voluntarily takes the RET scoring must request such action on the water and/or by other means thus properly notifying the Race Committee prior to leaving the race area and/or by notification of race committee in shortest time practicable.

**15.2** For races in the PHRF classes the scoring is on the basis of Time-On-Time (TOT).

## 16 SAFETY REGULATIONS

**16.1** Prior to her first start of each day boat shall check-in with the RC by passing the RC boat's stern on starboard tack.

**16.2** A boat that retires from a race shall notify the race committee as soon as possible.

**16.3** Boats must be equipped in accordance with Federal Equipment Requirements for Recreational Vessels.

**16.4** Boats must carry ground tackle sufficient for anchoring offshore of hazards in the racing area, a bucket, a flashlight, a compass and a first aid kit.

**16.5** RC assumes a VHF marine transceiver is onboard and useable by each boat involved in an MPYC Club Race race.

**16.6** All participants must wear a PFD while racing.

## **17 EQUIPMENT AND MEASUREMENT CHECKS**

A boat or equipment may be inspected at any time for compliance with the class rules and sailing instructions. On the water, a boat can be instructed by a race committee official to proceed immediately to a designated area for Inspection.

## **18 OFFICIAL BOATS**

Official boats are recommended to be marked with the burgee of MPYC.

## **19 RADIO COMMUNICATIONS**

**19.1** The Race Committee may broadcast information regarding MPYC racing events. The failure of any boat to hear the broadcast information from the Race Committee shall not be grounds for granting redress.

**19.2** A boat shall neither make radio transmissions while racing nor receive radio communication not available to all boats. This restriction also applies to mobile telephones. All communications involving safety are allowed.

## **20 ELIGIBILITY AND ENTRY**

**20.1** Except for invitational races, the boat owner must be a member of MPYC. If the owner is not on board, then at least one crewmember must be a member of MPYC. The RC Chairperson may waive this rule under special circumstances.

**20.2** Boats may enter by submitting a completed Entry Form, Liability Waiver, PHRF Monterey Bay Rating Certificate when applicable, and Racing Fee. Only a properly entered boat will be scored.

## **21 RACE COMMITTEE DUTY**

**21.1** Each boat's skipper is required to provide adequate RC support when scheduled.

**21.2** A minimum of 3 RC personnel is recommended on Race.Com; when additional MPYC boats are used, it is recommended that each shall be manned with at least two persons. Each boat used shall include a member of MPYC. In all cases at least one person per boat shall be "Realistically qualified and experience" to operate such boats

**21.3** Failure to provide competent race committee staff will be grounds for disqualification from the MPYC 2018 Season Championship.

## **22 PRIZES**

The Race Chairperson, per the customary MPYC practice, will determine trophies and perpetual trophy awards. Generally, trophies are awarded for first, second and third place finishers in each class for each series of races and specialty races; except a class or race with less than 9 entries may be awarded trophies for only first or only first and second place finishers at the discretion of the Race Chairperson.

## **23 DISCLAIMER OF LIABILITY**



**Competitors participate in the regatta entirely at their own risk.** See RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
